

DtC Shipments Rose 18% in Value During 2016

Direct-to-consumer (DtC) shipments from U.S. wineries were up 5% in December 2016 from December 2015. Data from Wines Vines Analytics/ShipCompliant indicate annual sales rose 18% in 2016 versus a year earlier, extending previous years' gains. Sales totaled \$187 million in December 2016, and \$2.3 billion for the year. December case volume remained above average, increasing 9% over December 2015 to 464,868. Rising demand for lower-priced bottles helped drive activity.


DIRECT-TO-CONSUMER SHIPMENTS

DtC shipment sales topped \$187 million in December 2016, 6% higher than in December 2015.


DIRECT-TO-CONSUMER SHIPMENT VOLUME

DtC shipments are a vital part of the business of wineries producing 5,000 to 49,999 cases annually. These producers claimed 47% of the 5 million cases shipped DtC in 2016. Wineries producing 50,000 cases and up accounted for just 26% of shipments.
